Statement of Issue: In accordance with the desire of the Town of Belleair and in conformance with the Florida Department of Transportation's functional classification of roads, Indian Rocks Road (G-697) and Rosery Road (C.R. 52), within municipal limits. will be maintained by said Municipality, and Mehlenbacher Road, also within same Municipal limits, will be maintained by Pinellas County.

Recommendation: I recommend the Board of County Commissioners approve the Agreement between Pinellas County and The Town of Belleair, which acknowledges reclassification of Indian Rocks Road (C-697) and Rosery Road (C.R. 52) as part of the City Street System with maintenance of these roads to be the responsibility of said Municipality, and acknowledges reclassification of Mehlenbach Road to a Collector facility and the maintenance, thereof, to be the responsibility of Pinellas County, and that this Board authorize the Chair to sign and the Clerk to attest the subject Agreement.

## WITNESSETH:

WHEREAS, Florida Statute 334.03 Paragraph 23 states in part, that the County Road System shall consist of all collector roads in the unincorporated areas and all extensions of such collector roads into and through any incorporated area, and;

WHEREAS, the Florida Department of Transportation through a statewide functional classification of all public roads has classified C 697 (Indian Rocks Road) and C.R. 52 (Rosery Road) as part of the City Street System, and Mehlenbacher Road as Collector facilities within the Municipal limits of the Town of Belleair, and;

WHEREAS, the Florida Legislature has stipulated that maintenance responsibilities will be assigned based upon functional classification of roads to be effective no later than July 1, 1982, and;

WHEREAS, the Board of County Commissioners is authorized by Section 335.04(4), Florida Statutes, 1978, to enter into agreements with the Department of Transportation, municipalities, or other political subdivisions, to provide for acceptance or relinquishment of maintenance responsibilities on public roads, and;

WHEREAS, this Agreement designates maintenance responsibilities in conformance with the current Florida Department of Transportation's functional classification of public roads,

NOW, THEREFORE, IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. The Town of Belleair agrees to comply with the Pinellas County Comprehensive Road Plan by acquiring right-of-way through dedication or other means as land is platted or developed.
- The Town of Belleair agrees to obtain County approval for any traffic control devices to be established on County Numbered Roads.
- 3. The Town of Belleair agrees to require the issuance of a County Utility license for driveway connections and utility installations or adjustments on County Numbered Roads which lie within the Municipal limits.

- 4. The north half of Mehlenbacher Road from t 697 (Indian Rocks Road) to the asterly Municipal limits of the Town of Belleair (approximately .75 mile), shall be designated as County maintained roads and shown as such on the Official Map of Pinellas County, Florida Numbered County Road System, and shall be subsequently maintained by the County with General County Funds.
- 5. C 697 (Indian Rocks Road) from Mehlenbacher Road to the easterly Municipal limits of the Town of Belleair (approximately 1.79 miles) and C.R. 52 (Rosery Road) from Cypress Avenue to the easterly Municipal limits of the Town of Belleair (approximately .17 mile), currently classified as County Numbered Roads on the Official Map of Pinellas County, Florida Numbered County Road System dated April 7, 1970, shall be deleted from said Map and shall be subsequently maintained by the Town of Belleair with funds of said Municipality.
- Traffic Control and signing, including maintenance thereof, within the corporated limits of the Municipality, shall be the sole responsibility of the Municipality.
- 7. This Agreement shall not take effect until right of way maps covering the road segments have been recorded with the Pinellas County Clerk of the Circuit Court.
- 8. This Agreement shall continue in full force and effect unless and until , mutually terminated by Resolution.
