

AGREEMENT

Between

PINELLAS COUNTY and the CITY OF BELLEAIR BLUFFS

THIS AGREEMENT made this 30th day of October 1979 between PINELLAS COUNTY, a political subdivision of the State of Florida, and the CITY OF BELLEAIR BLUFFS, a municipal corporation of the State of Florida.

W I T N E S S E T H:

WHEREAS, Florida Statute 334.03 Paragraph 23 states in part, that the County Road System shall consist of all collector roads in the unincorporated areas and all extensions of such collector roads into and through any incorporated area, and;

WHEREAS, the Florida Department of Transportation through a statewide functional classification of all public roads has classified Mehlenbacher Road as part of Collector facilities within the Municipal limits of the City of Belleair Bluffs, and;

WHEREAS, the Florida Legislature has stipulated that maintenance responsibilities will be assigned based upon functional classification of roads to be effective no later than July 1, 1982, and;

WHEREAS, the Board of County Commissioners is authorized by Section 335.04(4), Florida Statutes, 1978, to enter into agreements with the Department of Transportation, municipalities, or other political subdivisions, to provide for acceptance or relinquishment of maintenance responsibilities on public roads, and;

WHEREAS, this Agreement designates maintenance responsibilities in conformance with the current Florida Department of Transportation's functional classification of public roads,

NOW, THEREFORE, IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

Comprehensive Road Plan by acquiring right-of-way through dedication or other means as land is platted or developed.

2. The City of Belleair Bluffs agrees to obtain County approval for any traffic control devices to be established on County Numbered Roads.

3. The City of Belleair Bluffs agrees to require the issuance of a County Utility license for driveway connections and utility installations or adjustments on County Numbered Roads which lie within the Municipal limits.

4. Mehlenbacher Road from Indian Rocks Road (C-697) to the easterly Municipal limits of the City of Belleair Bluffs (approximately ¼ mile), currently maintained by the City of Belleair Bluffs, and currently not designated as a County Numbered Road on the Official Map of Pinellas County, Florida Numbered County Road System, dated April 7, 1970, shall be wholly maintained by Pinellas County with General County Funds.

5. Traffic Control and signing, including maintenance thereof, within the corporated limits of the Municipality, shall be the sole responsibility of the Municipality.

6. The transfer of maintenance responsibilities by this agreement shall be accomplished in accordance with the provisions of Section 335.04, Florida Statutes, 1978, as limited by Section 335.04(4) therein.

7. This Agreement shall take effect on the date of acceptance by the Board of County Commissioners and shall continue in full force and effect unless and until mutually terminated by resolution.
